#### SECTION 6 — ACCIDENTAL RELEASE MEASURES

#### SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Inorganic #4. Store with hydroxides, oxides, silicates and carbonates. Store in a cool, dry place. Moisture sensitive material, store in a Flinn Chem-Saf<sup>TM</sup> bag. Keep container tightly closed (P233). Use only in a hood or well-ventilated area (P271).

## SECTION 8 — EXPOSURE CONTROLS, PERSONAL PROTECTION

Wear protective gloves, protective clothing, and eye protection (P280). Wash hands thoroughly after handling (P264). Use only in a hood or well-ventilated area (P271).
